ORDINANCE NO. 13-~~04~~UC

AN ORDINANCE OF THE CITY OF REPUBLIC, WASHINGTON, AMENDING CHAPTER 10.12 OF THE REPUBLIC MUNICIPAL CODE TO ADD A LOADING ZONE WITH CERTAIN RESTRICTIONS ON A PORTION OF CLARK AVENUE WITHIN THE CITY OF REPUBLIC, AND TO PROVIDE FOR PENALTIES FOR A VIOLATION THEREOF.

WHEREAS, the City Council of the City of Republic, Washington, has determined that it is in the best interests of the City residents and the public at large to amend Republic Municipal Code to add a section to Chapter 10.12 to establish a loading zone with certain restrictions on a portion of Clark Avenue within the City, and to provide for penalties for a violation of such section.

NOW, THEREFORE, the City Council of the City of Republic, Washington, do ordain as follows:

SECTION 1 - AMENDMENT.

A. A new section 10.12.045 of the Republic Municipal Code shall be added, which reads as follows:

10.12.045 Establishment of Loading Zone. A loading zone shall be established on a portion of Clark Avenue described as follows: That portion of the West side of Clark Avenue South beginning at a point which is approximately 153' South of the intersection of 8th Avenue West and continuing South for a distance of 32' to its terminus, and as marked and designated by sign posting of the City of Republic as required in Section 10.12.060 of the Republic Municipal Code. Such designated area shall be 32' in length, and shall be hereinafter referred to as the "Loading Zone."

During the hours of 6:00 a.m. to 9:00 p.m., no vehicles shall park for a period of longer than 30 consecutive minutes within the Loading Zone. During such time period, the Loading Zone shall be used solely for loading and unloading of vehicles for the adjacent businesses.

B . 10.12.070 Republic Municipal Code which reads as follows:

10.12.070 Violation - Penalty. Parking of a vehicle in violation of Sections 10.12.020 through 10.12.040 of this chapter shall be a civil infraction. Civil infractions under this chapter shall be

assessed a civil penalty of not more than \$50.00. Such penalty shall be in addition to any expenses incurred by the owner of the vehicle under Section 10.12.060 of this chapter.

be and is hereby amended to read as follows:


10.12.070 Violation – Penalty. Parking of a vehicle in violation of Sections 10.12.020 through 10.12.045 of this chapter shall be a civil infraction. Civil infractions under this chapter shall be assessed a civil penalty of not more than \$50.00. Such penalty shall be in addition to any expenses incurred by the owner of the vehicle under Section 10.12.060 of this chapter.

SECTION 2 – SEVERABILITY. If any section, subsection, paragraph, sentence, clause or phrase of this ordinance is declared unconstitutional or invalid for any reason, such decision shall not affect the validity of the remaining parts of this Ordinance.

SECTION 3 – EFFECTIVE DATE. This Ordinance shall take effect after its passage by the Council, approval by the Mayor and five (5) days after publication as required by law.




